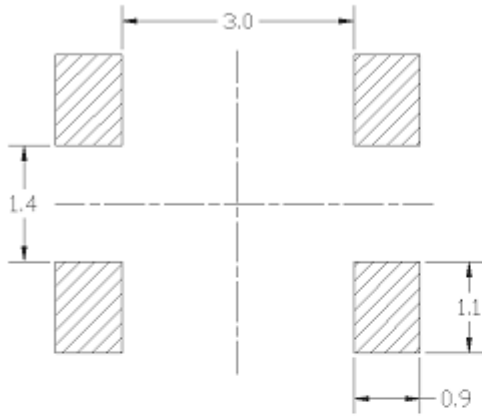

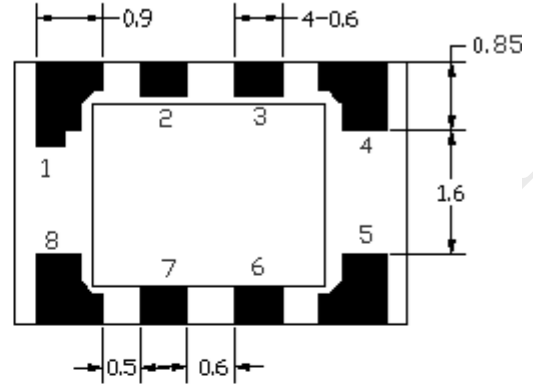


2. Mechanical Structure(mm)

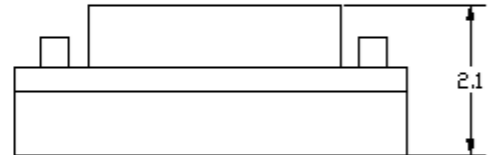


Solder pad layout

Bottom view



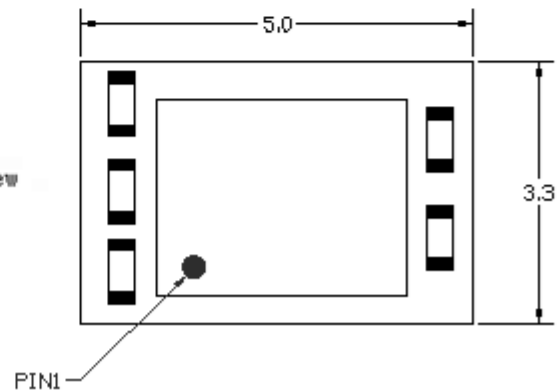
Side view

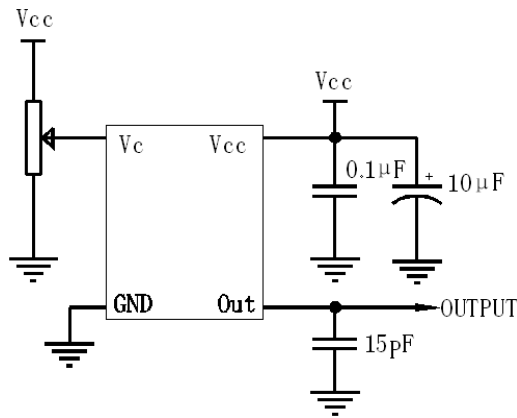

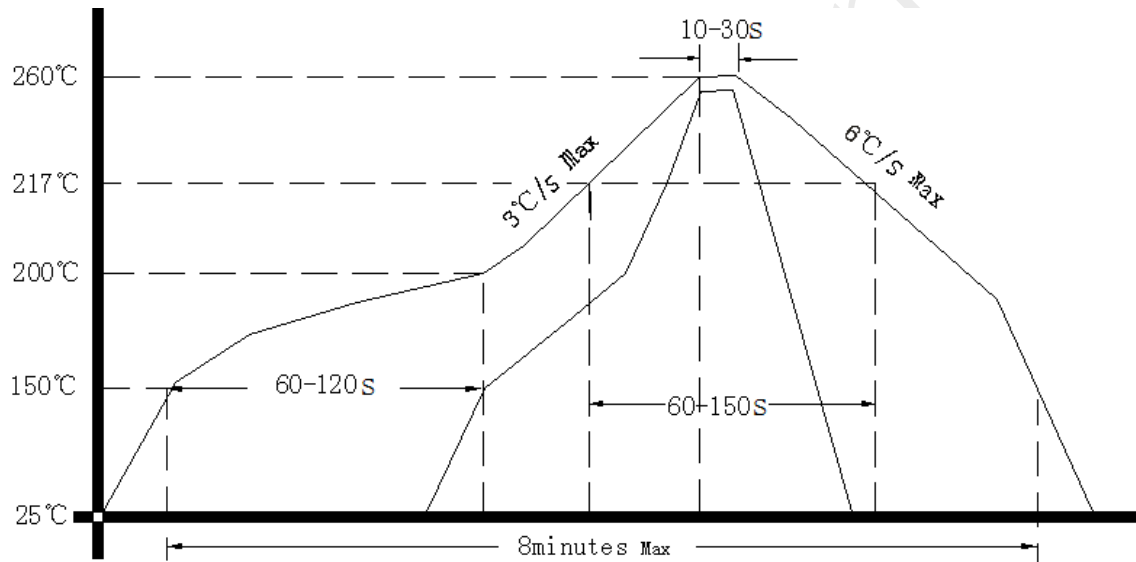
